The District continues to seek input from the school's community members during regular parent group meetings, community comment at Board meetings, ASB meetings, School Climate Committee meetings, certificated and classified staff meetings, parent conferences, IEP, SST, 504, and SART meetings, parent, staff and student surveys, as well as informally during pick up and drop off of students, and regular phone calls and emails between staff and community members.

Based on input received through the above mentioned means, The school community supports in person instruction that includes small class sizes, as well as additional support for students' differing academic, social, emotional, physical, and mental health needs. Based on this input, the ESSER III funds will be used to decrease student to staff ratios, and provide students with small group and individual high dose academic tutoring and social emotional supports.

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
